



### INCONSISTENCY

Nothing contained in this deed shall be deemed to authorize the trustees/ Board/ or any other Functionary/'s to do any act which may in any way be construed statutory

modifications thereof and all activities of the trust shall be carried out with a view to benefit the public at large, without any profit motive and in accordance with the provisions of the Income-tax Act, 1961 or any statutory modification thereof.

**OBJECTS:-**

a. To spread education and for achieving the said object to establish, acquire, maintain, run, develop and improve and assist in the establishment, maintenance, running, development, improvement and extension of schools, colleges, workshops, institutions for computer education and training, to establish, maintain or acquire library or libraries, to establish hostels for students, to grant individual scholarships for poor, deserving and needy students for elementary and higher education.

**Other objects:-**

- i. **Educational** – to run, maintain or assist any other institution for coaching, guidance, counseling or vocational training.
- ii. **Medical** – to run, maintain or assist any medical institution, nursing home or clinics or to grant assistance to needy and indigent persons for meeting the cost of medical treatment.
- iii. **Relief of the poor** – to give financial or other assistance in kind by way of distribution of books, notebooks, cloths, uniforms, or meals for the poor and indigent and to the persons suffer due to natural calamities.
- iv. **To acquire property for the sole use for public good by making it available for public purposes as for example, housing a library clinic, crèche and/or as a community hall to be available for public use as training classes, seminars, discourses and other public functions for benefit of the community in general.**
- v. **Other objects of general public utility** – i. to acquire property for the sole use for public good by making it available for public purposes as for example, housing a clinic, crèche and/or as a community hall to be available for public use as training classes, seminars, discourses and other public functions for benefit of the community in general, to undertake any other activity incidental to the above activities but which are not inconsistent with the above objects.



**PROVIDED** the Trust may assist/donate the other **TRUST** to carry out the various objects mentioned in the objects clause in such manner and to the extent the Trustees may decide upon from time to time.

**BENEFICIARIES:** The beneficiaries are a section of the public and not specific individuals.

**PROPERTY USE:** That the funds/ property of the trust will be used only for the objectives of the Trust.

**FUNDS:** The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. J. To establish, small scale industries, handicrafts center, vocational training center in different manners or any other unit for the purpose to achieve the object of the trust.

K. To purchase, lease, hire, exchange or otherwise acquire any moveable or immovable property anywhere in India and also to acquire existing institutions suited for the object of the trust and to sell montage depose of exchange improve manage develop, invest, with draw or invest and otherwise deal with any stocks,



share bonds, monies, securities and all kind of movable property for all or any other above objective for which the trust is established.

- L. To determine the manner in which bills, notes, receipt, cheque, releases contract and document which shall sign or executed by or on the behalf of the trust.
- M. To raise or burrow any some of money from time to time at their discretion for the purpose of the society and to secure the repayment of such term and condition in all respect as they think fit.
- N. To accept any gift or donation to purchase lease or otherwise acquire all articles and properties moveable which the trust for the purpose thereof may from time to time think proper to acquire for the object of the society.
- O. To sell improve manage develop exchange lease let under lease sub-let mortgage dispose of or otherwise deal with whole or any part of property of the trust.
- P. To construct upon any premises acquired for the purpose of building or buildings in furtherance to the object of the trust. Alter add to or improve any building upon such premises or to take any building on a rent for the running of the program and other affairs of the trust.
- Q. To appoint any person or persons to collect donation and subscription and to recruit members on the behalf of trust.
- R. To appoint any person or persons to carry on the routine work or business of trust whether or remuneration or otherwise.
- S. To amend, delete or add to the rules and regulation of the trust which may be deemed necessary to carry out the objective of the society.
- T. To interpret and implement the rules and the regulation prescribed herein

#### Section:-C

#### Rules and Regulations;

In these and following expressions Act.

1. Governing body means the governing board of the organization.
2. President means the chief functionary of the trust appointed in the manner of these rules.

3. Vice president means vice chairman of the trust appointed in the manners of these rules.

4. General Secretary means the general secretary of the trust appointed in the manner provide in these rules.

5. Secretary means the secretary of the trust appointed in the manner provided in these rules.

6. Treasure means the treasure of the trust same appointed in the manner provide in these rules.

7. Two executive members elected by the Board comprising of the President, Vice President General Secretary and the Treasure and two other members appointed on the same pattern and rule in the trust. Who can be removed by the Board of the trust hereinbefore prescribed.

#### **METHOD TO BECOME A MEMBER:**

A person who is desirous to become a member of the trust shall apply for membership in the prescribed application from to the trust .the governing board shall consider the application at the meeting and may admit the application as a member.

#### **SUBSCRIPTION**

Membership is not subject to pay any fee or subscription.

#### **CATEGORY OF MEMBERSHIP**

The trust shall have only individual membership and no subscription or fee is by the member.

#### **CESSATION OF MEMBER**

A governing board may terminate the membership of any member who fails to comply with any of the condition a stipulated by the governing board in this behalf or any other sufficient cause. A member shall also cease to be a member if he resigns if



he is of unsound mind become insolvent or is convicted of criminal offence involving moral turpitude in the event of member of the governing board either has power to admit another person in his or her place.

#### **RE-ADMISSION**

A member who resign or was removed from the membership of the trust may seek re-admission submitting of fresh application as required in the manner prescribed in these rules of governing board and governing board shall have the discretion to re-admit or reject the application. The reason for rejection or membership shall be communicated to the person concerned.

#### **MEMBERSHIP REGISTRATION**

There shall be a membership register kept on registration office of the trust and their shall be entered the name and the addresses of members of trust.

#### **MEMBERS RIGHTS AND PRIVILEGES**

The member shall have right to attend and vote at meeting to be elected as a member of the governing board but shall not entitle to receive any part of the fund of the trust by way of profit or may other manner.

#### **NOTICE OF MEETING QUORUM AND VOTE**

**Notice** :- 21 clear days of notice shall be given for each meeting. The notice shall ordinarily be given in writing and sent by post and proof posting shall be sufficient for purpose of deciding that the notice is given.

**Quorum**:- One third of the member of the governing board shall from quorum for the purpose of transacting business of the governing board except for adjourn meeting for which quorum is necessary.

**Vote**:- In the meeting of the governing board decision shall be arrived at on the basic of majority vote. In case of tie due to equal number of vote, the president shall have right to cast vote to finalize the decision.

**Resolution**:- The resolution regarding any decision can be passed by the circulation of the resolution .It is not mandatory to meet at one place for passing the resolution.

## **POWERS AND DUTIES OF THE OFFICE BEARERS**

### **1. PRESIDENT/CHIEF FUNCTIONARY**

The governing board shall elect a president from among its member of the governing board whose term of office shall be three years and he shall be eligible for re-election on expiry of his/her absence the vice president if he/she is present shall preside over the meeting. To delegate any of the power to the vice president he/she all the power and charge of the trust.

### **2. Vice President:**

The vice president of the trust shall have all the powers and duties of the president when he/she is absent. He/she shall have that specific power of duties which are assigned to him by the president from time to time.

### **3. General Secretary:**

The governing board shall elect a general secretary from among the members of the governing board whose term of office shall be three years. He/She shall be eligible for

re-election of his/her term of office. The president shall preside over all meeting. In his/her absence the Gen Sec shall preside the meetings.

#### **Duties of Gen Secretary:**

- a) To conduct correspondence with sympathizer in furtherance of the aims and objective of the trust.
- b) To conduct all correspondence on the behalf of trust.
- c) To call the meeting of the governing board and make the arrangements is consultation with governing board for the annual meeting other meetings and functions of the trust.
- d) To prepare the agenda for the annual and extra ordinary meeting of the trust accordingly to the rules in consultation with the president.
- e) To submit the annual meeting and annual reports of the work of the trust together with audited statement of annual account.
- f) To submit estimate of revenue and expenditure for the next year as approved by the governing body with the help of president.
- g) To do such other works as may be entrusted to him by the trust or the executive committee or the president in furtherance of its aims and objectives.
- h) He shall be act as the Chief functionary in the absence of the Chief Functionary.

#### **4. Secretary:**

- a) He/She shall function in accordance with the direction of the president and the governing board. He/She shall keep the minutes and shall be responsible for carrying out all the correspondence pertaining to the business of the trust and shall file the list of member governing board with register of trust.
- b) He/She shall be responsible for the execution of all Activities and policies laid down by the governing board and shall attend to statutory requirement imposed of the trust.
- c) He/She shall be responsible for coordination among the professional and other staff of the trust, delegating duties and responsible in consultation with other officer of society.
- d) He/She sign all deeds and documents on the behalf of trust.
- e) He shall in consultation with appropriate authority convince meeting of the governing board, annual general meetings, extra ordinary general meetings prepare minutes and circulates them among concerned members and authorities.



- f) He shall be responsible for appointment and dismissal of officers and other staff in consultations with president/vice president.

**LITIGATION and Person of the Trust :-** In case of litigation the trust shall sue and shall be sued in the name of president of The Trust. Any document or proceedings requiring authentications by the trust shall be signed by the president / Chief functionary.

**CLEARITY:-** The functionaries Of The trust shall report to governing body on policy matters and the president/vice president for day to day working and he/they can Co-ordinate his/their responsibilities to others through or with the approval of the president/vice president.

The treasurer of the trust shall be appointed by the governing board from among the members of governing board for a term of the three years and he/she shall be eligible for re-appointment on expiry of the term of office he/she shall be responsible to the president and governing board in all matters concerning accounts, funds and the properties of the trust. The treasurer shall be responsible to prepare and submit annual income and expenditure statements and balance sheets of the trust, within three months from closing of the financial year of the trust before the Governing board.

**EXECUTIVE MEMBERS:** - Two executive member shall be appointed by the governing board of the trust. He/She shall be re-appointed on the expiry of tenure as per the board decision.

**Sub- Committees:**

The Governing board shall have powers to appoint sub-committees and delegates powers subjects to such conditions as they think fit for specific purpose and take appropriate actions in furtherance of the powers vested in the governing board.

**Audit:**

Every balance sheets and income and expenditure account of the trust shall be audited by one or more auditors to be appointed as herein after mentions.

### Auditors:

- A) The Trustee shall keep proper books of account of all the assets, liabilities and income and expenditure of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March. i. The accounts of every year shall be audited by a Chartered Accountant or a firm of Chartered Accountants who shall be appointed, for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.
- B) The auditor of the trust shall have the right access at all reasonable times to the book of accounts and vouchers of the trust, shall be entitled to acquire from the president and the members of the board and all officers and employees of the trust such information and explanations as may necessary for the performance of duties of the auditors.
- C) The auditors shall make a report Public to the members of the trust, of the account examined by him and every balance sheet and income and expenditure shall be laid before the annual general body meeting the trust.

### OPENING AND OPERATIONS OF BANK ACCOUNT OF THE TRUST

The bank account of the trust be opened and operated by joint signatories nominated by the trust governing board. The governing board can authorize the vice president to nominate the signatories of the bank account. The funds of the trust shall be deposited with schedule bank.

**IRREVOCABLE** This Trust is irrevocable.

**AMALGAMATION** The trustees may amalgamate the trust with another Charitable Trust or Institution having similar objects with prior permission of the Charity Commissioner/Court/any other law as may be applicable for the time being.

### MANAGING COMMITTEE

The Governing Board, if or when desired, or as Per the directions of the government, shall frame a managing committee comprising of educationalists, locals and



others to see, and overlook, guide for smooth running of the institution. The trustees could depute a person or persons from among them to be part-time or full time worker in the institution against reasonable remuneration.

**WINDING UP** In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust/Organisation whose objects are similar to those of this Trust with the permission of the Charity Commissioner / Court / any other law as may be applicable for the time being. The Trustees shall be indemnified against all losses and liabilities incurred by them in the execution of the Trust and shall have a lien over the funds and properties of the Trust for such indemnity.

**Financial year:-**

The financial year of the trust shall be from 1<sup>st</sup> April of any year to 31<sup>st</sup> March of the next Year.

**Elections:-**

The elections of the governing board shall be held later than 30<sup>th</sup> July/August of every three years through secret ballots / rising of hands/ unanimously decisions. 21 days clear note shall be given to the members about the date of elections. Nominations for elections to the governing shall be submitted to the president not later than a week but before the date of election. Each candidate shall be proposed and recommended by two members and he shall state on the nomination from that he is agreeable to function as a member of the governing board if elected.

**Utilization of funds:**

The funds of the trust shall be used exclusively for achieving the objective for which trust has been established and no part of the fund will be paid to any member by way of the profit or dividends and any other manner.

The surplus fund of the trust shall be invested only in the accordance with the provision of income tax (Act 1961). The prior approval of central board of direct taxes.



**Tenure of the governing board:-**

The tenure of the governing board of the trust shall be three years.

**Legal suits:-**

The president / chief functionary shall sue and be sued on behalf of the trust. He shall represent the trust in legal proceedings and in documents all suits against on behalf of the trust will be suited in district court of Ganderbal.

**Amendments:-**

The amendments to the rules and regulations of the trust shall be done in accordance with relevant section of the act.
