ORDER NO:-71-GEN OF 2021 DATED:-31-07-2021

Subject:- "Grant of Extension in the period of Affiliation/Up-gradation in respect of Academic Institutions of Kashmir Division".

Ref:- "Minutes of the Affiliation Committee meeting held via circulation during the month of July 2021".

In pursuance to the Resolutions passed by the Affiliation Committee at its meeting held via circulationduring the month of July 2021 and sequel to the approval, sanction is hereby accorded to the grant of:-

- Extension the period of affiliation for a period of (05) years in respect of (27) and (64) Academic Institutions, as per the details given in Annexure "A& B" respectively to this Order.
- 2) Up-gradation upto High/Higher Secondary level for a period of (02) years in respect of (08), (03) and (06) Academic Institutions, as per the details given in Annexure "C, D & E"respectively to this Order.
- 3) Regularization of provisional Up-gradation granted previously in respect of (01) Academic Institution to run Class 9th for the academic session 2019-2020 and Extension in the period of its affiliation to run Classes 9th& 10th for the academic session 2020-2021, as per the details given in Annexure "F" to this Order.
- 4) Extension in the period of offiliation for a period of (05) yearswith regularization of previous period in respect of (01) Academic Institution, strictly in compliance to Orders of the Hon'ble Court directions as per the details given in Annexure "6" to this Order.
- 5) Regularization of previous period of affiliation in respect of the academic institutions figuring at Serial No:-"2" of Annexure "A" and Serial No's, 2, 4, 5, 10, 22, 23 and 45, of Annexure "B", in whose case provisional facilities have been released.

Further the Affiliation Committee also resolved:-

- That the condition of obtaining of Feasibility from the DSEK be waived-off and the cases considered for Up-gradation, as per the past practice.
- ii) To consider the NOCs issued by the Fire & Emergency Department with the subject "Fire Safety recommendations" on provisional basis and the Board shall ask the concerned Department to issue clear-cut NOCs in respect of aspiring academic institutions seeking Board affiliations.


Terms and conditions: -

- a) That the Affiliation shall strictly be governed by the terms and conditions, as laid down vide SRO 123 read with 292 and other relevant Government Orders, JKBoSERegulations and Resolutions of the Affiliation Committee, as prescribed/passed from time to time.
- b) That the Academic Institutions having their Managing Bodies awaited shall furnish their revalidated Managing Bodies within (06) month, failing which their affiliation shall be liable to suspension/termination instantaneously.

- c) That the deficienciesas reflected against the concerned Academic Institutions shall be addressed within a time frame of (03) months, from the date of issue of affiliation Order, failing which their affiliation shall be re-visited.
- d) That the Academic Institutions shall be required to furnish renewed statutory certificates immediately after expiry of their validity.
- e) That all the Private Academic Institutions shall be under an obligation to adhere to the fee structure, as fixed by the Fee Fixation Committee, failing which their affiliation shall be liable to suspension/termination without any notice.
- f) That during the course of Examination(s), all the Academic Institutions shall keep their premises including Examination Hall(s) and other related infrastructure/facilities at the disposal of JKBoSE, during the course of Examinations or as and when asked for and ensure necessary Heating & Cooling arrangements at their respective institutions.
- g) That all the Academic Institutions shall strictly adhere to "JKBoSE Curriculum" for all the Classes and also adopt the Books and Academic Calendar prescribed for the purpose. Deviation, if any, in this behalf shall invite imposition of penalty.
- h) That all the Academic Institutions shall necessarily ensure proper arrangement for co-curricular and extra-curricular activities.
- i) That in order to maintain proper hygiene and sanitation, all the Academic Institutions shall ensure separate Toilet facilities for Boys and Girls, in addition to "Change Room facility", in respect of female staff and students.
- j) That in order to ensure academic development, all the Academic Institutions shall include and nominate at least one member from their Parent Association in the Managing Committee.
- k) That the financial business including payment of salary to the staff shall be made by the Academic Institutions through the Nationalized Banks only and also remit the EPF/CPF (whichever is applicable) with the required contribution of the employee and the employer, with the concerned authority.
- 1) That all the Academic Institutions shall strictly ensure submission of case(s) for grant of Extension in the period of affiliation one year ahead of expiry of their term of affiliation, failing which late fee, as admissible under rules shall be levied from the defaulters.
