**Subject: REVIEW/MODIFICATION OF FEE STRUCTURE OF "R.P SCHOOL
NAGBAL, GANDERBAL.**

The fee of the school was fixed vide order No. 369 FFRC of 2024 dated: 11-12-2024. A review application has been filed by the school management on 30.01.2025 seeking an enhancement of the fee structure by 20% in Tuition Fees and 10% in Annual fees over and above fee fixed by the Committee vide order dated 11.12.2024. The school has stated that both Tuition and Annual fee does not meet the requirements of the school and the fee for session 2023-24 has not been fixed by the Committee. The file was submitted in 2023 and previous fee was approved by the Committee up-to the session 2022-23. Whereas this Committee has approved an enhancement of only 6% in average. The School is running in deficit of Rs.4 lakhs approximately as per the records available in the file. In order to compensate deficit amount the review application is allowed with below mentioned revision.

Approved Revision:

Tuition Fee: 2% hike in Tuition Fee over and above the fee fixed vide above referred order, and one time annual fee @Rs.10000/-, Rs.11000/- and Rs.12000/- (Nursery class new entrants only) for the sessions 2024-25, 2025-26 and 2026-27 respectively.

The revised fee structure is as follows:
